Since 2008, I've volunteered at DEC. I help out in the classroom and work one-on-one with students who are struggling with math basics or those who are close to passing their math test and just need additional help.

I choose to volunteer because I want to make a difference in my community. My background--a business degree and appraisal business--gave me math skills. I want to help students who don't like math. I want them to at least end up seeing they can do math and, every once in a while, find it helpful in life.

Over the years, I've worked with a variety of students, ranging in age from 16 to probably 65. EVERY student I've worked with has been my most memorable. I learned from each of them and they learned from me. One that particularly stands out was a single mom of 4 boys (ages 6 months to 8yrs.), who was living in the shelter while she was attending classes. She managed to attend regularly, took careful notes, and learned everything I taught her. She was quite an inspiring young woman!

I continue to volunteer at DEC because I believe that the teachers and staff are improving lives in our community. I am blessed with each interaction I have. I enjoy seeing students go from being totally confused or uninterested in math to the 'light bulb' moment when they understand what they're learning. I believe everyone at DEC is making a difference and I'm happy to be a part of it!

## When Education Alone is Not Enough

Boosting Opportunities & Occupations for Self-Sufficient Transitions (BOOST)

Beginning this July, learners seeking to transition from adult education into college or into the workforce will have additional support from the Durango Education Center. Low-income parents and individuals will have the opportunity to receive wraparound support to maximize the skills and knowledge they gain through our adult education programs. Students will receive guidance along

every step of the process to becoming self-sufficient, beginning with career planning, lasting throughout education and training, and culminating with job placement.

The launch of DEC's BOOST Program is the result of multiple efforts now in collaboration. In 2014 a needs assessment was conducted with the support and vision from a philanthropic couple new to Durango, to determine whether self-sufficiency services were needed in our community. The result was yes, this program would fill the gaps between several existing programs and could make a difference in breaking the cycle of poverty. Simultaneously, DEC, after

years of recognizing the need for services beyond secondary education, added a self-sufficiency goal to its strategic plan and began in earnest preparing for implementation.

Modeled after the highly effective Project Self-Sufficiency ([www.ps-s.org](http://www.ps-s.org)) in Larimer County, Colorado, DEC's BOOST Program will provide learners with individualized case management that promotes problem-solving and accountability. Early in the program, learners will develop a realistic self-sufficiency budget that will serve as a guidepost throughout their participation. As learners are progressing through the program, they will have access to scholarship funds to assist with education and living expenses that are unmet elsewhere. That way they can stay on track and meet their goals.

With generous start-up funding from the Michael and Elaine Moravan Foundation, the BOOST Program will assist individuals in moving from poverty to economic self-sufficiency. Participants will receive counseling, emotional support, and crisis intervention, as they transition away from housing programs, food stamps, temporary aid, and other services and into independence. Adult learners often

## Director's Note

Another academic year is coming to a close at the Durango Education Center; each day has been filled with little successes that are meaningful to our learners.

A mother improves her reading skills by four grade levels in one semester. Not only are we improving her literacy, but that of her children as well. Another student, barely an adult, with no parental support or stable housing, earns his GED. He is now considering college, which was never an option before.

Yet another student advances 3 levels in English speaking and listening. He can now communicate with international companies and broaden opportunities for his company upon his return to Columbia.

We couldn't do any of this without you. Your ongoing support allows us to help each and every one of the 250 adult students that we will serve this year. Your contributions ensure that our community's at-risk learners receive an excellent education.

Our center's test success rate is one of the highest in Colorado. In 2014 we had a 100% passing rate in both the Science and Social Studies exams and very high in Reasoning Through Language Arts (96%) and Math (89%). Our learners are getting a solid education because our community invests in education for all.

Nationally, adult education is in flux, learner expectations are shifting, and funding is at risk. I am confident that our learners will continue to thrive because of your commitment to literacy. Together we are truly making a difference!

lack the support network and resources they need to overcome some obstacles that many of us view as minor. The BOOST Program provides participants with a champion and mentor to help them complete their goals.

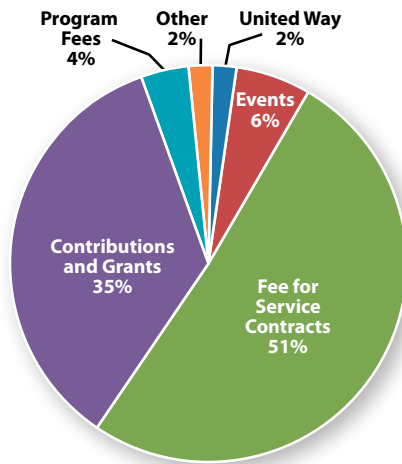

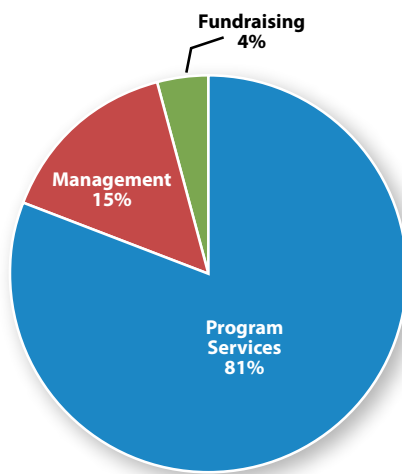

## Program Updates

### GED Is No Longer the Only Option

The GED, or tests of general educational development to measure high school equivalency, started in 1942 when the military requested the American Council on Education to develop the tests for soldiers who had enlisted before completing high school.

The tests have changed four times since then, the most recent being in 2014 in conjunction with the merging of the non-profit American Council of Education with the for-profit Pearson Publishing company. The result is a more rigorous, more expensive, computer-only exam that has resulted in the emergence of two additional high school equivalency exams (*see chart*).

Nationally, the number of GED graduates plummeted in 2014. Approximately 482,000 fewer learners in the US earned the GED in 2014, an 89% decrease from the previous year. This trend affected us locally; in Durango we went from 82 graduates in 2013 to ten in 2014.

The changes in the GED have led other states to adopt alternative tests to better serve their learners. While Colorado has been slow to respond, adult education leaders in Colorado are working on legislation to adopt another test alternative. "We need a more appropriate option for those who want better jobs or technical training; the GED is only appropriate for our students who are planning on continuing immediately with their academic studies to earn a two or four-year degree," states Stephanie Moran, Program Manager.

At the DEC, we continue to offer the GED since it is currently the only option for our students. We teach people from across the secondary academic spectrum, from the truly illiterate and up to high school-level skills. Improving skills across grade levels in literacy and numeracy helps all learners reach important goals that improve the likelihood of passing the GED, being better prepared for the workplace, and increasing the academic success of their children.
