- English as a Second Language classes in English and civics;
- Community education and industry certification testing to improve work skills and employability; and
- Career transition and support activities leading to self-sufficiency.

In 2015, we served 283 students in our adult literacy programs, provided childcare to 26 children while their parents attended classes, and administered 503 industry certification exams.

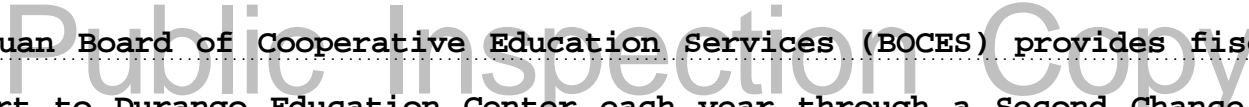
