- English as a Second Language classes and citizenship preparation;
- Community education and industry certification testing to improve work skills and employability; and
- Career transition and support activities leading to self-sufficiency.

In 2016, we served 264 students in our adult literacy programs, helped 36 students earn a GED, provided childcare to 30 children while their parents attended classes, and administered 503 industry certification exams.
